Ghormley Cabin Rental Agreement

Camp Ghormley will provide the following “amenities” as part of my stay:

- A cabin with no less than 8 bunk style beds
- A private bathroom for my family and myself
- A microwave
- To-go meals upon request at the following times:
 - Thursday Cont. Breakfast (served at 8 AM) - \$6
 - Friday Cont. Breakfast (served at 8 AM) - \$6
 - Saturday Cont. or Hot Breakfast (served at 8 AM) - \$6 (Cont.) or \$7.50 (Hot)
 - Saturday BBQ Dinner (served at 5:30 PM) - \$11
 - Sunday Cont. Breakfast (served at 8 AM) - \$6
- A sealed container to store food inside my cabin
- Picnic tables for outdoor meals
- S'more materials and roasting sticks for my family

Camp Ghormley will NOT provide the following as part of my stay at Ghormley:

- Bedding/toiletries (i.e. towels)
- Indoor meeting area (no common spaces are allowed to be used due to COVID)
- Internet access
- Shared communal bathroom/shower access (each cabin will have their own bathroom)
- Facilitated camp activities (Ghormley can't provide “programming” due to current COVID restrictions)
- Shared equipment (i.e. basketballs, soccer balls, frisbees, etc.)
 - You are welcome to bring your own as we have a basketball court, volleyball court, open field area, and frisbee golf course
- BBQ - You are welcome to bring your own portable BBQ to grill/cook food. You must comply with U.S. Forest Service and Yakima County rules and regulations pertaining to the use of BBQs at Camp Ghormley.

Facility Use Agreement (Please initial below)

I understand and agree that my group may only use the facilities, buildings, or camp activities which are agreed to in this agreement, or for which we are otherwise given express permission to use.

Our group is responsible for preventing damage to Camp Ghormley property during our stay. We will not write on or in any Ghormley buildings, or deface Ghormley property in any way.

We will report all damage to the Camp Host. Our on-site leader is responsible for damage by our group members (except damage arising from normal wear). If we damage Ghormley property, we agree to pay for repairs.

We will check out with our Camp Host prior to our departure.

Other Camp Policies (Please initial below)

We understand that Ghormley is a 100% drug and alcohol-free facility. We will not bring drugs or alcohol to Ghormley, and we will not smoke on the camp property (past the end of the camp driveway on Lost Lake Road).

We will not bring firearms or fireworks on the grounds.

We will not use ATVs for recreational use on Ghormley property

We will not bring pets to Ghormley. We understand that failure to follow this may result in our dismissal from the camp.

We will practice respectful behavior while at Ghormley.

In respect of other guests at Ghormley, we will observe the quiet hours of 11:00pm-7:00am.

We understand that Ghormley staff has the right to enter any facilities if it suspected that prohibited items are on camp property.

We understand that under certain conditions the U.S. Forest Service or Yakima County will impose a complete ban on fires. If the camp staff informs us of a burn ban, we will honor it by not building any fires.

We understand that our group may be asked to leave Ghormley if we do not uphold these policies.

Safety and Supervision (Please initial below)

We understand that Ghormley is unable to provide medical services and that we will be responsible for our own first aid (including first aid supplies) and emergency transportation. We understand that the closest emergency medical facility to Ghormley is Virginia Mason Memorial Hospital, located 36 miles from Ghormley in Yakima, WA.

If any injuries occur while we are at Ghormley, we will obtain an Incident Report from our host and submit it before we leave.

We agree to provide appropriate supervision of minors in our care for the duration of our time at camp. We agree that under no circumstances will minors be left unattended, including and especially overnight.

We are responsible for our own negligence. Any and all claims resulting from negligence on the part of our group members are not the responsibility of Ghormley.

COVID-19 Related Safety

I agree that everyone in my group will complete a health screening process upon arrival to Ghormley, including the temperature of each member of the group being taken upon arrival.

I agree that nobody in my group will approach and maintain a distance within 6 feet with anyone outside of my family (those in my cabin group).

I agree that, in accordance with current Washington State and Yakima County COVID-19 health requirements, everyone* in my family group will wear a mask while within 6 feet of anyone outside my family group, including the Ghormley staff. (Mask wearing is not required while engaging in recreational activities). *Some exceptions may be made in limited cases for health and safety reasons, and must be approved in writing and in advance of arrival by the Camp Ghormley Executive Director.

I understand and agree that I and my group will be asked to leave Ghormley immediately if any of the following is true or becomes known to me or the Ghormley staff during our stay:

- (1) I, or someone in my group, have traveled outside the United States in the last 14 days
- (2) I, or someone in my group, has a known exposure in the past 14 days to someone with a confirmed case of COVID-19.
- (3) I, or someone in my group, becomes ill with symptoms related to COVID-19 while at Ghormley.

I understand that if I fail to agree or uphold these requirements, that I and my group may be asked to leave immediately.

Notice Regarding Footwear

By its very nature camp is situated on terrain that may include undulations, tree roots, rocks, and other characteristics that make mobility more difficult. We therefore strongly suggest that you and your guests take extra care when walking across our campus. We also suggest that sturdy walking shoes be worn, and that NO SANDALS OR FLIP-FLOPS be worn when visiting camp. Failure to follow these instructions will increase your risk of injury. We also ask that you share this information with any relatives or guests who may be visiting camp with you.

COVID-19 Acknowledgement

We (Camp Ghormley) have taken enhanced health and safety measures—for you, our other Guests, and Staff Members. You must follow all posted and verbal instructions while visiting Camp Ghormley.

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and guests with underlying medical conditions are especially vulnerable.

By visiting Camp Ghormley, you voluntarily assume all risks related to exposure to COVID-19.
